- 1) The following Question and Answer have been provided:

Question 2:

- a) Do we need to submit all individual names at our company who would like to participate during the industry engagements?
- b) Also, is this the preferred communication method to receive the form or is it through one of your other procurement portals?

Answer 2:

- a) Yes, in accordance with the rules of engagement form, all individuals interested in participating in the NextGen CIBIDS Industry engagement must agree to and sign the mandatory form.
- b) Once completed, the mandatory form (found on pages 6-9 of the LOI), should be sent to the Next Generation CIBIDS procurement team at: TPSGC.PASCIBI-APCIBIDS.PWGSC@tpsc-pwgsc.gc.ca.

Question 3:

Section 7 outlines that any disclosures that a vendor marks as confidential information would be subject to the Access to Information Act. This Act provides certain rights, obligations and procedures for the Crown and a vendor when faced with an ATIP third party request. In the Rules of Engagement, Section 9 – Dispute Resolution, subsection 9.2, it appears that ultimately a representative of Canada (Contracting Authority) makes the final decision on any dispute. In a situation where a vendor objects to any specific disclosure by the Crown to the third party requestor, can Canada confirm that this situation would not be deemed a “dispute” and therefore would not be subject to this RFI’s Contracting Authority, but rather fall under the mechanisms contained within the Access to Information Act?

Answer 3:

Yes, disclosure of commercially sensitive or proprietary information would fall under the Access to Information Act R.S., 1985, c. A-1 and would not be subject to the dispute resolution process identified in the LOI.
