QUESTIONS AND ANSWERS – SERIES 001:

Question 1: We see references to delivery of TangoDown stubby vertical grips, with estimated annual quantities but we cannot find any reference to required delivery address and delivery periods from receipt of orders, or where delivery time/capacity data should be submitted.

Answer 1: The delivery address is located under section 6.4.3 Delivery Points and the delivery date under section 6.3.1 Delivery Date of the solicitation document. Each call-up will specify the delivery date required. Delivery time/capacity data can be submitted on the cover page of the standing offer solicitation under “Delivery Offered” or within your technical offer.

Question 2: Is there any previous record of procurement for similar purchase? If so, please share call up report with us if possible.

Answer 2: Yes. There was 12 call-ups placed against the previous standing offer M759460689 for a total of \$263,128.22 over a period of 3 years.

Question 3: What will be the individual minimum call-ups for each order?

Answer 3: The minimum call-up quantity per item listed in Annex A will be 100.

Question 4: How many total call-ups will you be placing in one year?

Answer 4: Unfortunately, this is unknown. Call-ups will be placed on an “as and when requested” basis. Please refer to Annex A for the estimated annual quantity for each item, but actual usage may vary from these amounts.

Question 5: We are wondering if you are looking specifically for the Tango Down Grips as per the solicitation or are you possibly open for alternative manufacturers such as FAB Defence or Magpul. The reason for asking is that we can possibly get better prices on those compared to the Tango Down as well as faster delivery.

Answer 5: No, we require the same product in order to maintain commonality across the RCMP. The Tango Down grips were first chosen through a previous competitive process.
