Questions from Bidders and Responses

- Question 1: Can you please confirm the quantities and units for line item 6 – Stripping (including grubbing)? The current amount appears to be high.
- Response 1: The estimated Stripping quantity of 27,600 m³, is correct based upon an estimated stripping depth of 0.3 m. Stripping (including Grubbing) will be measured for payment on the in-situ volume of material removed during the stripping process, surveyed in cubic metres (survey completed prior to and upon completion of stripping), in accordance with Section 31 24 14 – Roadway Excavation, Embankment, and Compaction.
- Question 2: The drawings indicate that many of the existing csp culverts are to be removed / abandoned. Can you please specify the requirements for abandonment?
- Response 2: Existing CSP and Wood Stave culverts shall be excavated, removed and disposed in accordance with the requirements of Section 02 41 13 – Selective Site Demolition of the Contract Specifications. The “abandon” note on the contract drawings should be neglected.
