Response (R) to Question (Q) 3-6:

Q3. Would the resource mean the service provided such as Graphic Design Services?

A3: No. The resource means the specific personnel who will be tasked with this contract.

Q4: Please define what constitutes a former public servant?

A4: Former Public servant is defined on page 8 of the RFP document.

Q5: Can protected materials be included as part of the work portfolio?

A5: Yes. given that it is EC material and all parties have security clearance, we have no issues with this. The mode of delivery through the RFP process must respect the guidelines for protected material, aka encryption for protected B.

Q6: The international desk of the PSPC Contract Security Program advises us we cannot request such clearances in advance of contract, but rather you can request it if we are selected. They advise us that through their alternative solutions process, such clearances can be obtained quickly before contract award. Can you confirm our bid will not be rejected for not yet possessing the required security clearances?

R6: The RFP will remain unchanged. Security clearances are required at bid closing.
