Enquiries - Request for Standing Offers - Clause # 2.4

To ensure consistency and quality of information provided to Offerors, significant enquiries received and the replies to such enquiries will be provided simultaneously to Offerors to which the Request for Standing Offers has been sent, without revealing the sources of the enquiries.

Here are the questions which we have received until now:

Question #1: Can you please define "project"? Would it be safe to assume that both project and contract are one of the same? Meaning, if our company had a contract with a client from November 2019 till October 2020, could all of the work under that contract be considered as "Project"?

Answer #1: Yes, by the term "project" we mean any work carried out under the same contract having been completed during a period "X" of the contract. This period must be demonstrated. With this demonstration, we want to know your ability to meet our translation needs.
