**Question 142**

Attached is amendment 16 which included a list of DND owned inventory to be transferred as of May 2021. Is this all of the inventory that will be transferred, or is this just the first delivery (first of three)?

**Answer 142**

This is DND's entire inventory as of May 21, 2021. This inventory represents stock held at both Montreal and Edmonton Depots. This means that the numbers provided constitute the first and second phase of the transfer. The exact breakdown will be provided with updated numbers upon contract award. The third phase is residual Inventory held by contractors and cannot be estimated at this time. Furthermore, it is important to note that these numbers will change as time passes and they are only a "snapshot" in time for planning purposes.

All other terms and conditions of the solicitation remain the same.
