QUESTIONS AND ANSWERS:

Question 1	There are two associations; Medical Review Officer Certification Council (MROCC) and American Association of Medical Review Officers (AAMRO) that issue certification for medical review officers. SAMHSA does not provide accreditation for MROs. In Canada the only professional licence that is acceptable to the two certification bodies is a provincially licensed Medical Doctor (MD) as osteopathy is not recognized the same in Canada as it is in the U.S.
