AMD 005 – Q&A – July 26, 2021	
Q18	With the increased global nature of business, employees of a Service Provider are no longer all located in Canada. As employees of the Service Provider, however, any employees located outside of Canada are still governed by the policies and legal obligations of the Service Provider. Therefore, provided that all GOC data remains within Canada, on servers certified by Canada, would any additional security requirements apply for employees that may be located outside of Canada?
A18	When a Prime Contractor has employees working abroad and accessing Protected information, the Prime Contractor must initiate a subcontract (or service agreement if it is within the same company) in order to obtain security clauses and validate proper clearances. This can only be initiated once the Prime Contract has been awarded.
