This amendment to the solicitation is raised to extend the closing date August 11, 2021 and to answer the following bidder questions:

**Q1. Can we submit our bid by fax?**

A1. Yes. The fax number is found at Part 2, paragraph 2.2, Submission of Bids.

**Q2. What is the contact name that I have to mention on the quote?**

A2. The technical authority's contact information will only be provided at contract award. It is not required to attach a formal quote, however, bidders must submit their financial bid as per Part 3, Section II, Financial Bid.

**Q3. In reference to Annex B, 2.0 Optional Requirements, Table B-2, our company provides a one-year standard warranty which can be extended by 2 to 4 years but we would require that it is paid with the instrument. Alternatively, we can provide a one-year warranty with the instrument and any additional extended warranty periods would need to be purchased outside the solicited requirement. Can you accommodate this?**

A3. The requirement will not be changed to accommodate your request. All financial bids must be submitted in accordance with Part 3, Section II Financial Bid.
