Enquiries - Request for Standing Offers - Clause # 2.4

To ensure consistency and quality of information provided to Offerors, significant enquiries received and the replies to such enquiries will be provided simultaneously to Offerors to which the Request for Standing Offers has been sent, without revealing the sources of the enquiries.

Here are the questions which we have received until now:

Question #3: At **Attachment 1 to Part 4 – Technical Criteria**, Section **2. Point-Rated Technical Criteria**, under **RTC-1**, "**Supporting documents** are letters from clients confirming the execution of translation services or invoices showing the number of words translated.". One of our clients provides us with a "contract/performance summary", listing all the words translated within the last year under their RFSO. Would this document be acceptable as "supporting documents" for one of the projects?

Answer #3: Yes, this type of document is acceptable as long as it demonstrates the number of words translated in the last five (5) years prior to the closing date of this Request for Standing Offer.
