The following changes in the tender documents are effective immediately. This addendum will form part of the contract documents.

1. Response for RFI:

- .1 Question: As Zone A is for correctional building projects and proposal submissions require correctional facility examples, are images a rated criteria?
Please clarify if submissions that do not include images of secure correctional facilities will be penalized.

Response: Offerors must demonstrate it meets all the criteria set out in SRE 3 Submission Requirements and Evaluation. It is up to each offeror to decide how to present the evidence to demonstrate that it meets SRE3. Note that images will count towards the page limitation.

- .2 Question: In Zone B are project images a rated criteria?

Response: See Response .1 above.

- .3 Question: Could the client please clarify the difference between a renovation project and a rehabilitation project?.

Response: Renovation is making the built environment new again without altering much of existing footprints, occupancies, functions, and appearances. Rehabilitation is making significant enhancements on the built environment for its footprints, occupancies, functions, innovative technologies and aesthetic improvements.
