Question #1

NRCan requires that the ability to communicate orally and in writing in English and French can be satisfied across a team and not that it is a requirement that each individual team member be able to communicate orally and in writing in both English and French.

Question #8

Does NRCan have an anticipated start date for the project?

Answer: As soon as a supplier is selected- Anticipated start date: September 2021

Question #9:

Answer: Staff will be available for the duration of the contract.

Question # 12

<u>Answer:</u> An electricity network that is able to function independently from a centralized national grid. Yes, this is considered microgrid experience

Question #13

Does NRCan have an approved budget envelope for this project? If so, can NRCan provide a maximum budget or a range of budget available for this assignment?

<u>Answer: A</u> financial limitation is not included as part of this RFP process. Please refer to the applicable trade agreements that are captured at Part 1 – General Information of the RFP.

Question #14

At page 10 of 41, the "Financial Bid" section states: "The total amount of applicable taxes must be shown separately". Please confirm if this is required as there is no provision on the Financial Proposal Form to provide this information.

Answer: Applicable taxes must be separate and not included in the bid price

Question #15

Please confirm which, if any, meetings required in the Deliverables Tasks (Section 4, pages 28-29 of 41) will require attendance in person versus teleconference/virtual presentation.

Answer: No in person attendance required. Virtual attendance is acceptable.

Question # 16

Does NRCan require all proponent team members to hold a valid Reliability Status upon a proposal submission or can this be obtained after the award and before the contact signing?

Answer: Please refer to Part 6, 6.1: At date of bid closing the following conditions must be met

- (a) the Bidder must hold a valid organization security clearance as indicated in Part 7 Resulting Contract Clauses;
- the Bidder's proposed individuals requiring access to classified or protected information, assets or sensitive work sites must meet the security requirements as indicated in Part 7
 Resulting Contract Clauses;
- (c) the Bidder must provide the name of all individuals who will require access to classified or protected information, assets or sensitive work sites;

Question # 17:

Requirement R4 - "interpreting financial statements" - is this about any financial statement of a company or is it about annual reports of power utilities?

<u>Answer:</u> Yes, this is primarily related to annual reports and financial statements of power utilities, but could also include financial statements from municipalities and Indigenous governments.

Question #18:

Could you please clarify the difference between R1 (Northern policy/programs) and R7 (Northern or indigenous policy issues)?

<u>Answer:</u> Northern policy/ programs is strictly related to work in the three territories, as well as Nunavik and Nunatsiavut, whereas Northern or Indigenous policy issues includes policy work across Canada.
