CCGS LIMNOS - MOORING WINCHES SOLICITATION AMENDMENT 003

The Solicitation Amendment 003 is been raised to answer a set of questions (Section A) and modify the bid solicitation (Section B) as follows:

- I. change the time limit for Bidders to confirm their attendance to the Optional Vessel Visit; and
- II. correct the Mandatory Bidders' Conference text.

A. Questions and Answers:

6. Question:

Would you adjust the intended work period to start November 1st, 2021? This would allow a significant portion of the work to be accomplished before the busy winter work season.

Answer:

No, the work period cannot be advanced.

We could move the work period around June 2022 if needed. The vessel would be in a crewed refit. Dates would have to be determined by the Technical Authority, but it would be a three week window around June 2022.

7. Question:

Can the vessel be re-located to another shipyard to carry out the installation if the work period cannot be adjusted?

Answer:

No, the vessel must remain at the Canada Centre for Inland Waters (CCIW).
