## **PART 1 - GENERAL INFORMATION**

### **1.1 Statement of Requirement**

1.1.1 The requirement is detailed under Annex "A" of the resulting contract clauses.

### **1.2 Debriefings**

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

### **1.3 Canadian Content**

This requirement is subject to a preference for Canadian Goods and Services.

### **1.4 epost Connect service**

This bid solicitation allows bidders to use the epost Connect service provided by Canada Post Corporation to transmit their bid electronically. Bidders must refer to Part 2 entitled Bidder Instructions, and Part 3 entitled Bid Preparation Instructions, of the bid solicitation, for further information.

## **PART 2 - BIDDER INSTRUCTIONS**

### **2.1 Standard Instructions, Clauses and Conditions**

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the [Standard Acquisition Clauses and Conditions Manual](https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual) (https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual) issued by Public Works and Government Services Canada.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

The [2003](#) (2020-05-28) Standard Instructions - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the bid solicitation.

Note: Bids will not be accepted if emailed directly to this email address. This email address is to be used to open an epost Connect conversation, as detailed in Standard Instructions [2003](#), or to send bids through an epost Connect message if the bidder is using its own licensing agreement for epost Connect.

### **2.3 Enquiries - Bid Solicitation**

All enquiries must be submitted in writing to the Contracting Authority no later than 5 (FIVE) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

## **2.4 Applicable Laws**

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Newfoundland and Labrador.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

## **2.5 Bid Challenge and Recourse Mechanisms**

- (a) Several mechanisms are available to potential suppliers to challenge aspects of the procurement process up to and including contract award.
- (b) Canada encourages suppliers to first bring their concerns to the attention of the Contracting Authority. Canada's [Buy and Sell](#) website, under the heading "[Bid Challenge and Recourse Mechanisms](#)" contains information on potential complaint bodies such as:
  - Office of the Procurement Ombudsman (OPO)
  - Canadian International Trade Tribunal (CITT)
- (c) Suppliers should note that there are **strict deadlines** for filing complaints, and the time periods vary depending on the complaint body in question. Suppliers should therefore act quickly when they want to challenge any aspect of the procurement process.

## **PART 3 - BID PREPARATION INSTRUCTIONS**

### **3.1 Bid Preparation Instructions**

- If the Bidder chooses to submit its bid electronically, Canada requests that the Bidder submits its bid in accordance with section 08 of the 2003 standard instructions. The epost Connect system has a limit of 1GB per single message posted and a limit of 20GB per conversation.

The bid must be gathered per section and separated as follows:

Section I: Technical Bid  
Section II: Financial Bid  
Section III: Certifications  
Section IV: Additional Information

- If the Bidder chooses to submit its bid in hard copies, Canada requests that the Bidder submits its bid in separately bound sections as follows:

Section I: Technical Bid (1 hard copy)  
Section II: Financial Bid (1 hard copy)  
Section III: Certifications (1 hard copy)  
Section IV: Additional Information (1 hard copy)

If there is a discrepancy between the wording of the soft copy on electronic media and the hard copy, the wording of the hard copy will have priority over the wording of the soft copy.

- If the Bidder is simultaneously providing copies of its bid using multiple acceptable delivery methods, and if there is a discrepancy between the wording of any of these copies and the electronic copy provided through epost Connect service, the wording of the electronic copy provided through epost Connect service will have priority over the wording of the other copies.

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

Canada requests that bidders follow the format instructions described below in the preparation of hard copy of their bid:

- (a) use 8.5 x 11 inch (216 mm x 279 mm) paper;
- (b) use a numbering system that corresponds to the bid solicitation.

In April 2006, Canada issued a policy directing federal departments and agencies to take the necessary steps to incorporate environmental considerations into the procurement process [Policy on Green Procurement](https://www.tbs-sct.gc.ca/pol/doc-eng.aspx?id=32573) (https://www.tbs-sct.gc.ca/pol/doc-eng.aspx?id=32573). To assist Canada in reaching its objectives, bidders should:

- 1) use 8.5 x 11 inch (216 mm x 279 mm) paper containing fibre certified as originating from a sustainably-managed forest and containing minimum 30% recycled content; and
- 2) use an environmentally-preferable format including black and white printing instead of colour printing, printing double sided/duplex, using staples or clips instead of cerlox, duotangs or binders.

#### **Section I: Technical Bid**

In their technical bid, Bidders should explain and demonstrate how they propose to meet the requirements and how they will carry out the Work.

**Section II: Financial Bid**

Bidders must submit their financial bid in accordance with the Basis of Payment.

**3.1.1 Electronic Payment of Invoices – Bid**

- (b) An evaluation team composed of representatives of Canada will evaluate the bids.

**Important:** To be deemed responsive, bidders must meet the mandatory technical criteria. It is not acceptable to simply say your proposed product(s) meets each of the mandates. In a technical bid document, bidders must demonstrate how their product(s) meet each of the technical criteria.

It is required that supporting technical documentation, including but not limited to, specification sheets, technical brochures, photographs or illustrations be provided with the bid at solicitation close. It is the Bidder's responsibility to ensure that the submitted supporting technical documentation provides detail to prove that the proposed product(s) meet the mandatory requirements

## **PART 5 – CERTIFICATIONS AND ADDITIONAL INFORMATION**

Bidders must provide the required certifications and additional information to be awarded a contract.

The certifications provided by Bidders to Canada are subject to verification by Canada at all times. Unless specified otherwise, Canada will declare a bid non-responsive, or will declare a contractor in default if any certification made by the Bidder is found to be untrue whether made knowingly or unknowingly, during the bid evaluation period or during the contract period.

The Contracting Authority will have the right to ask for additional information to verify the Bidder's certifications. Failure to comply and to cooperate with any request or requirement imposed by the Contracting Authority will render the bid non-responsive or constitute a default under the Contract.

### **5.1 Certifications Required with the Bid**

Bidders must submit the following duly completed certifications as part of their bid.

- (c) If the parties cannot resolve a dispute through consultation and cooperation, the parties agree to consult a neutral third party offering alternative dispute resolution services to attempt to address the dispute.
- (d) Options of alternative dispute resolution services can be found on Canada's Buy and Sell website under the heading "[Dispute Resolution](#)".

## ANNEX "A" - STATEMENT OF REQUIREMENT

### **1.0 Scope**

#### 1.1. Objective:

Through competitive bidding process, National Research Council's Design & Fabrication Services requires the supply of a manual variable speed lathe.

#### 1.2. Background:

NRC/DFS St. John's Branch provides manufacturing service capabilities in support of the Ocean Coastal River Engineering (OCRE) research center. DFS fabricates high precision prototype and production assemblies to meet high tolerance requirements of the various manufacturing technologies and associated performance evaluation testing.

To fill the mandate, the NRC requires a manual lathe. The latter is required to replace an existing manual lathe to facilitate the research center manufacturing agenda.

### **2.0 Technical Requirements:**

The contractor must supply equipment that meets the following technical requirements:

- 1- Must have minimum swing of 13" and 25" between centers
- 2- Must have a 3 headstock gear ranges
- 3- Must have Infinitely variable spindle speed between 15 – 3250 rpm using a variable speed spindle drive

- 5- Must have a leadscrew reversing box (for thread cutting). This will allow reversing leadscrew while chuck is turning.
- 6- Must have an electromagnetic spindle brake

- 9- Must have a cast iron base with surfaces sloped to prevent coolant accumulation.

- 0- Must comply with CSA or applicable standards for lathe equipment including all guarding (chuck, chip guard, leadscrew cover, access doors.)
- 1- Must be connected to 575v, 3 phase power, 10HP motor.
- 2- Ways shall be coated with PTFE for minimal wear and long machine life. Design of bed to provide accuracy and minimize wear. Bed ways should be hardened and ground.
- 3- Must have spindle with precision tapered roller bearings
- 4- Must have a dynamic spindle brake.
- 5- Must come as complete kit with all necessary hardware for assembly.
- 6- Must have CSA approval for electrical by an Authorized agency.
- 7- Spindle nose to be D1-4 (to match existing tooling)
- 8- Must come with the following items, installation included:
  - a. 10" telescopic taper attachment
  - b. Steady rest – to 5 1/2"
  - c. Follower rest – to 3"
  - d. Quick change tool post w/ 4 holders
  - e. Micro position carriage stop
  - f. 8" 3-jaw chuck
  - g. 8" 4-jaw chuck
  - h. 2 axis digital readout (Accu-Rite 200 or equivalent)

### **3.0 Scope of Work:**

As part of the contract, the contractor must:

- 3.1 Deliver the equipment to NRC, St. John's, NL.
- 3.2 Complete installation of accessories as appropriate

### **4.0 Bidder Must Possess.**

- 4.1 The Bidder must demonstrate their ability to provide on-site warranty and service support, using service personnel authorized or trained by the machine manufacturer.
- 4.2 Bidders must explain how they propose to provide on-site warranty and service support within two business days notice from technical authority on all components of the machine. The contractor must use service personnel who are authorized or trained by the machine manufacturer.

### **5.0 Deliverables and Acceptance Criteria:**

- 5.1 The machine must be delivered by February 1<sup>st</sup> 2022.
- 5.2 Technical manuals (mechanical and electrical, PLC...) must be provided. Electronic versions are acceptable.

## **6.0 Support Provided by Canada:**

The contracted technical services or NRC will be responsible to do the electrical connection, install & set-up machine.

- 7.2 Fully satisfactory performance of the machine by NRC staff before final invoices are to be processed for payment. This will include the function of controls with all its features, capabilities and operation as per mandatory requirements.
