PART 1 - GENERAL INFORMATION

1.1 Statement of Requirement

The Department of National Defence (DND), Real Property Operations Detachment Borden (RP Ops Det Borden) has a requirement for the supply and delivery of approximately 3024 bags (with approximately 18.0 kg to 20.0 kg each bag) of water softening salt to be delivered approximately twice a year approximately every 6 months. Firm requirement of one (1) year with the option of three (3) one-year periods.

1.2 Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

1.3 epost Connect service

This bid solicitation allows bidders to use the epost Connect service provided by Canada Post Corporation to transmit their bid electronically. Bidders must refer to Part 2 entitled Bidder Instructions, and Part 3 entitled Bid Preparation Instructions, of the bid solicitation, for further information."

PART 2 - BIDDER INSTRUCTIONS

2.1 Standard Instructions, Clauses and Conditions

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the [Standard Acquisition Clauses and Conditions Manual](https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual) (<https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual>) issued by Public Works and Government Services Canada.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

The [2003](#) (2020-05-28), Standard Instructions - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the bid solicitation.

2.2 Submission of Bids

Bids must be submitted only to the Public Works and Government Services Canada (PWGSC) Bid Receiving Unit specified below by the date and time indicated on page 1 of the bid solicitation:

Only bids submitted using epost Connect service will be accepted. The Bidder must send an email requesting to open an epost Connect conversation to the following address:

Note: Bids will not be accepted if emailed directly to this email address. This email address is to be used to open an epost Connect conversation, as detailed in Standard Instructions [2003](#), or to send bids through an epost Connect message if the bidder is using its own licensing agreement for epost Connect.

It is the Bidder's responsibility to ensure the request for opening an epost Connect conversation is sent to the email address above at least six days before the solicitation closing date.

Bids transmitted by facsimile or hardcopy to PWGSC will not be accepted.

2.3 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than 10 calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

2.4 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Ontario.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

2.5 Bid Challenge and Recourse Mechanisms

- (a) Several mechanisms are available to potential suppliers to challenge aspects of the procurement process up to and including contract award.
- (b) Canada encourages suppliers to first bring their concerns to the attention of the Contracting Authority. Canada's [Buy and Sell](#) website, under the heading "[Bid Challenge and Recourse Mechanisms](#)" contains information on potential complaint bodies such as:

- (c) Suppliers should note that there are **strict deadlines** for filing complaints, and the time periods vary depending on the complaint body in question. Suppliers should therefore act quickly when they want to challenge any aspect of the procurement process.

PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION

4.1 Evaluation Procedures

- (a) Bids will be assessed in accordance with the entire requirement of the bid solicitation including the technical and financial evaluation criteria.
- (b) An evaluation team composed of representatives of Canada will evaluate the bids.

4.1.2 Financial Evaluation

The bidder must submit pricing for all line items in accordance with Annex 'B' – Basis of Payment, in Canadian Funds.

The price used in the evaluation will be the sum of Total Evaluated Price which is, Extended Price, calculated by adding the Firm Unit Price multiplied by the estimated annual usage of each Line Item in accordance with Annex B – Basis of Payment.

4.2 Basis of Selection

4.2.1 Basis of Selection - Mandatory Technical Criteria

A bid must comply with the requirements of the bid solicitation and meet all mandatory technical evaluation criteria to be declared responsive. The responsive bid with the lowest evaluated price will be recommended for award of a contract.

PART 5 – CERTIFICATIONS AND ADDITIONAL INFORMATION

Bidders must provide the required certifications and additional information to be awarded a contract.

The certifications provided by Bidders to Canada are subject to verification by Canada at all times. Unless specified otherwise, Canada will declare a bid non-responsive, or will declare a contractor in default if any certification made by the Bidder is found to be untrue whether made knowingly or unknowingly, during the bid evaluation period or during the contract period.

The Contracting Authority will have the right to ask for additional information to verify the Bidder's certifications. Failure to comply and to cooperate with any request or requirement imposed by the Contracting Authority will render the bid non-responsive or constitute a default under the Contract.

5.1 Certifications Required with the Bid

Bidders must submit the following duly completed certifications as part of their bid.

The period of the Contract is from Date of Contract Award to September 30, 2025 inclusive.

STATEMENT OF REQUIREMENT

1. BACKGROUND

- 1.1. The Department of National Defence (DND), Real Property Operations Detachment Borden (RP Ops Det Borden) is responsible for the ongoing maintenance of all the water softeners on the department's property;
- 1.2. As part of this responsibility there exists the requirement for the supply and delivery of approximately 3024 bags (with approximately 18.0 kg to 20.0 kg each bag) of water softening salt to be delivered approximately twice a year approximately every 6 months.

2. OBJECTIVE / GENERAL REQUIREMENT

- 2.1. The Contractor must provide approximately 3024 bags (with approximately 18.0 kg to 20.0 kg each bag with handle) of water softening salt to be delivered approximately twice a year (approximately every 6 months) for each contract year. This represents approximately 109,468.80 kg of salt per year.
- 2.2. The Contractor must provide all labour, equipment, materials, delivery and transportation for the delivery of water softening salt..
- 2.3. The salt must be Water Softening Salt with carrier friendly handles, as some water softeners are on upper levels of buildings so the plastic handles helps with ease of delivery.

3. DELIVERY REQUIREMENTS

- 3.1 Delivery day must be coordinated with the DND Project Authority or designated representative prior to delivery. Hours of Operation 7:30 am to 3:00 pm.

Delivery Location: Supply and deliver water softening salt to the Department of National Defence, RP Ops Det Borden, Plumbing Shop, Door 10, 16 Ramillies Road, Borden, Ontario

Frequency of delivery: Water softening salt to be delivered approximately twice a year during each contract period approximately every 6 months. Once in October and the other delivery in April, each delivery being approximately 54,734.40 kg of salt in 18.0 kg to 20.kg bags.

- 3.2 DND will provide unrestricted access to the site.

4. MANDATORY PRODUCT SPECIFICATIONS:

- a) Must be High Purity Solar Salt: evaporated naturally by sun and wind and must be a minimum 99% sodium chloride crystals.
- b) Must be formulated to resist mashing and bridging in order to minimize brine tank residue.
- c) Salt must be in bags with carrier friendly handles
