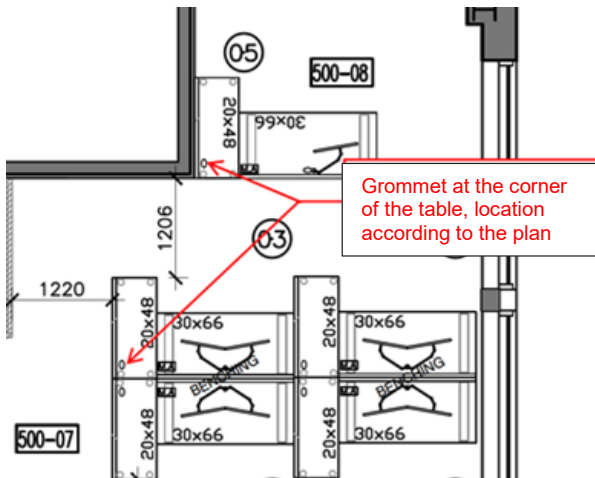

AMENDMENT 002 :**1) ANSWERING QUESTIONS FROM SUPPLIERS (3 to 6)**

QUESTION 3: Page 20 -Item 8 : Is it only a 20" x 48" surface with a grommet and without a base that is required?
What do you mean by "at the corner on the side of the adjustable table, see plan)"?

ANSWER 3: The item description is "4x tubular legs". Here is a clarification regarding the grommet required and its location on the table, valid for all 5x tables.



QUESTION 4: Page 27- Item 1: Bar Height Stool: Would it be possible to offer a 4-leg stool such as 6KBSBHxxLP15XXXROYX? Or a stool with a sled base, but an upholstered shell like the chair specified in the quote (there would be a family resemblance) such as 6KBSCHxxSY15XXXPOYX?

ANSWER 4: No

QUESTION 5: Page 27 - Item 3 : In the Excel file of specification, it is a monopod base which is specified. While in the detail of this request, it is 4 legs that are specified. Is it possible to submit a table with a base (monopod) such as the standard specifications of the Excel table Category 6?

ANSWER 5: No, the item must meet the additional notes.

QUESTION 6: Page 19 -Item 4 : For the electrical module, what do you mean by a "VOIP"?

ANSWER 6: This is a space for a phone jack - sometimes a space is left empty for the IT department to bring in their phone wire through the module.
