An additional consultation period will be available from 23 to 31 August 2021.

2. Under Paragraph 1.7 – Industry Interaction

Delete the following text.

1.7.3. Virtual One-on-One meetings between industry and Canada will be held over the period of 15 June to 22 July 2021.

1.7.5. One-on-One meetings will take place in 60 min slots between the hours of 9:00 am and 15:30 pm EDT during the period of 15 June to 22 July 2021 on a first come basis.

Insert the following text.

1.7.3. Virtual One-on-One meetings between industry and Canada will be held over the period of 15 June to 22 July 2021. An additional consultation period will be available from 23 to 31 August 2021.

1.7.5. One-on-One meetings will take place in 60 min slots between the hours of 9:00 am and 15:30 pm EDT during the period of 15 June to 22 July 2021 and 23 to 31 August 2021 on a first come basis.

All other terms and conditions of the RFI remain unchanged.
