QUESTIONS AND ANSWERS

Question 4: Extension Request - Given the workload, the requirement to get the client signed letters (in high vacation season) the current due date is not realistic we request an extension to the due day to September 14th.

Answer 4: The closing date has been extended to September 21, 2021. Please refer to Amendment 002, Solicitation Revision 1.

Question 5: Our company is requesting a 3-week extension to the closing date to this RFP due to the amount of internal research involved in demonstrating the significant volume of mandatory and point-rated billable days, as well as the constraints on reaching our clients and references due to summer vacations.

Answer 5: The closing date has been extended to September 21, 2021. Please refer to Amendment 002, Solicitation Revision 1.

Question 6: Our company is requesting that the enquiries deadline be amended to 5 calendar days prior to the closing date.

Answer 6: The number of calendar days before the bid closing date by which Bidders must submit enquiries to be answered by Canada will not be revised.

Question 7: Due to the complexity of the response including the requirement for signed client letters during a period where many clients are taking summer holidays, we respectfully request a 2-week extension to allow Bidders extra time to provide a thorough response.
