Question 1:

Can we bid in EUR for F5561-210467/B? If not, is there a protection on the exchange rate fluctuation?

Answer 1:

Bids that are made in a foreign currency will be converted to Canadian currency for evaluation. The Bank of Canada rate published by 16:30 ET on the bid closing date will be applied as a conversion factor to bids made in foreign currency.

As per section 3.1.2 Exchange Rate Fluctuation of the RFP and *SACC Manual* Clause C3011T: The requirement does not offer exchange rate fluctuation risk mitigation. Requests for exchange rate fluctuation risk mitigation will not be considered. All bids including such provision will render the bid non-responsive.
