### 5. Questions and Answers

- Q1. There is insufficient information provided in drawings for armour stone & rip rap. Unit of measurement is lump sum in unit price table. It is difficult to judge the exact or nearby quantity. Please provide adequate details on this issue.
- A1. The quantity is not identified but is limited to possible material in the existing pier. (we don't know how much of the material is boulders, rip rap or granular fill.) The intent indicated in section 35 31 and 01 11 00 1.4.16 is to place all suitable reclaimed Armour Stone and Rip Rap material at the toe of the SSP cells. We will issue an amendment drawing indicating the areas and limits of where the Rip Rap and Armour stone is to be placed.

Q2. Can you please share photos of the site so we have a realistic idea of the conditions?

- A2. Photos of the site will be shared in an amendment after the bidders' conference (see folder DSP 002 5P468-21-0063).
- Q3. What's the accommodation for labourers on site there?
- A3. In the park itself, we have camping and cabins. The contractor would be responsible for their own accommodations. The park is not making any provisions for that. Traditionally, we have recommended contractors stay in the Midland area or Honey Harbour/Port Severn.
- Q4. How many Contractors are in the call today?
- A4. It's an optional bidders conference, so it is not mandatory for all bidders to attend. Post-meeting note: three (3) Contractors were in fact on the call, not two (2).
- Q5. When is camping and cabins available to reserve until?
- A5. Visitor facilities are open up until and including Thanksgiving weekend.
- Q6. Is there any soil report available for the site so we know the refusal of the sheet piling? I'm concerned with soil conditions; do we excavate until it's clear - but that can leave you without any toe material. Especially in cell 3, is there a theory in place to overcome this without digging out the toe to get the sheet to the correct grade?
- A6. Most of the lakebed is sand, at least 1.5m of depth of penetration into the material. The only part that we know where there is cobble is around the end of Cell 3, it's just a matter of shifting 1 or 2 out of the way. Part of the contract also includes a requirement for the Contractor to drive test piles.
- Q7. Is there a deadline to submit questions?
- A7. Refer to SI02 of the Invitation to Tender.
- Q8. What type of floats are currently being used? Must the same floatation floats be used?
- A8. The existing floating dock is not changing; it is only being relocated. The existing concrete anchors are to be relocated.
- Q9. Are there any specifications for the timber used in the existing deck, as we might need to replace some sections when relocating?
- A9. None of the existing timber deck is being reclaimed or reused. Only the existing ramp to the floating dock is to be removed and installed at the east end of Cell 3.
- Q10. Will a soil report be issued?
- A10. No, the Contractor is required to install test piles as indicated in the documents, to confirm the embedment and length of piles.
