Amendment no. 001 is raised to provide a response to questions raised to date, to extend the bid solicitation closing date and an amendment to section 11.9 in Annex A, as follows:

- Q1 Mandatory technical criterion MT4^{PB} states “The Bidder must submit a description of the following items, in sufficient detail to allow verification of compliance, of its ability to initiate up to four PCP program deliveries of 32 students each per year. Within that year, the Bidder must also be able to graduate two of the three PCP programs.” And section 3.4 in Annex A, Statement of Work, states “The estimated number of PCP program serials for each year is one to two, and the average estimated number of CAF students per PCP program serial is between 20-24. These estimates are only an approximation given in good faith by Canada and does not constitute a contract guarantee. The training year runs from April to March.” Would Canada please confirm the maximum number of program serials that the Contractor must be able to initiate within a given year?
- A1 The Contractor must be able to initiate up to three program deliveries of 32 students each per year. Within that year, the Contractor must also be able to graduate two of the three programs.
- Q2 For mandatory technical criterion MT5^{PB} and section 13.4(b) in Annex A, Statement of Work, would Canada please consider amending the distance between the accommodations and the emergency/on-car training facilities from 30 km to 80 km?
- Also, would Canada please consider removing this as a mandatory technical criterion and add it as a point rated technical criterion?
- A2 The maximum distance between the accommodations and the emergency/on-car training facilities remains the same. After the Contract has been awarded, if unique situations arise, they will be considered. The objective is to ensure safety and that students are not spending a considerable amount of time being transported to/from the accommodations.
- Q3 Section 6.4 in Annex A, Statement of Work states “If requested, the Contractor must initiate up to three deliveries and complete up to two PCP programs throughout a year. Depending on the operational requirements, there may be a requirement to deliver two PCP programs concurrently, including the applicable students’ accommodations. The Contractor must provide instructors and preceptors and the accompanying materials for each delivery as identified in the approved task authorization.” Would Canada please confirm if “concurrently” refers to two programs that begin on the same date or two programs that overlap at some point of the respective programs (including the practicum)?
- A3 Concurrently can be two programs that begin on the same date or it can be two programs that overlap.
- Q4 Clause 6.4 under Part 6 states the use of individual PPE for work performed at government of Canada sites. Does this clause have any impact on PPE requirements for students?
- A4 Students will follow the provincial health measures in regard to PPE.

REASONS FOR AMENDMENT:

- 1.0 The Solicitation closing date is currently 02:00 PM Eastern Daylight Time (EDT) on 31 August 2021 and is extended to 02:00 PM EDT on 7 September 2021.
- 2.0 Annex A, Statement of Work, delete section 11.9 in its entirety and replace with:
- 11.9 Should an extension be required during the emergency and on-car portion due to factors such as student inability to achieve the required competencies, The Contractor will be reimbursed for accommodations and meals in accordance with the basis of payment, and the costs on a pro-rated basis for the emergency and on-car unit of study.
