LETTER OF INTEREST 875 Heron Road Rehabilitation Project (EP095-220899/A)

AMENDMENT 002

This Amendment 002 is issued to answer the following enquiries we have received:

QUESTION 002: Could you specify if a firm could respond to a future call for tenders concerning the rehabilitation project of 875 Heron Road, in the event that the firm has security clearance (reliability status) for its employees?

The document in the Letter of Interest indicates that certain zones could require a SECRET classification:

"SECURITY REQUIREMENTS

There will be security requirements in the RFQ and/or RFP phase at Reliability level; Secret might be required for access to certain areas."

Would that disqualify a firm with only reliability status?

ANSWER 002: The security requirements will be indicated later in the procurement process, however if deemed necessary to participate in the procurement process, proponents and/or their employees will be given the opportunity to apply to the proper security clearance in time to meet procurement deadlines.

QUESTION 003: Would you consider extending the closing date to September 29th?

ANSWER 003: Unfortunately our procurement schedule cannot allow for an extension, however as participation is not mandatory Canada would still consider answers received after the closing date, understanding that some decisions might already have been taken based on the other answers received.
