Amend/revise the Standard Contract Documents as follows:

1. QUESTIONS AND CLARIFICATIONS

Questions from bidders and responses as follows:

1. Question: Concrete driveways instead of spec'd asphalt driveways.

- Weather permitting activity not reasonable in proposed season.
- Springtime activity of asphalt contractor starts with largest projects and works down throughout summer.
- Cost of asphalt contractor to service remote area

Response: No concrete will not be permitted. Please provide asphalt as indicated in the contract documents

2. Question: Will special security clearance be required to work onsite?

Response: No security clearances required

3. Question: Vague instructions for number of trees to be replaced. Subject to client representative interpretation is un reasonable to account for.

Response: To clarify the information provided, tenderers shall assume removal of a total of 52 trees including 13 trees with a trunk diameter between 300-400 mm and 39 trees with a trunk diameter between 200-300 mm.

4. Question: To utilise new and existing storm line for dewatering procedure as required.

Response: Discharge to the existing and new storm lines is permitted provided that it is in compliance with the Contract Documents. Proponents' attention is drawn to Clause 1.5 in Specification Section 01 35 43.

5. Question: Stockpile material in grass area (West) of work site.?

- Lack of room on building site to stockpile materials required for construction, will save time and resources if materials can be stored on site.
- We will restore area back to original conditions after materials has been used.

Response: The contractor is permitted to use the area within the lot area of new construction. If additional space is require, the departmental representative will allocate an additional site area within reasonable proximity to the building site. The stored material should be fenced and under lock all the times. Contractor to use all occupational and health and safety measures to keep the material stored in a proper way
