SOLICITATION AMENDMENT # 008

This solicitation amendment is raised to:

1. Address the following questions submitted during the solicitation period as per RFP; and
2. Amend the RFP.

Additional questions that have been received by CRA and which are not addressed below will be answered in a subsequent solicitation amendment.

1. QUESTIONS AND ANSWERS

Q82. We request that Category 3 be divided into sub-categories that can be awarded to separate bidders to allow CRA to get the best options from the bidders who can provide the best value on the items required. Please consider the reasons for this request:

- Category 3 contains a broad variety of products that do not necessarily need to be procured from the same bidders (i.e. a sofa does not need to be supplied by the same bidder as the table, as they are different products). Even if they come from the same bidder, they may be coming from various manufacturers, so requiring they come from the same bidder does not guarantee they are from the same manufacturer.
- If Category 3 is not divided, it will eliminate Canadian Manufacturers from participating in this competition if they do not carry every product listed, or do not meet even one of the dimension specifications requested.
- Awarding it only one bidder would penalize bidders who are missing only a few items in Category 3 but could meet the majority of products requested.
- If a bidder cannot meet every line item in Category 3, they are then penalized in not being awarded points for being able to submit all three Categories.
- Please split off these products to their own sub-categories:
 - A) Tables/horizontal surfaces
 - 6A-1) Kitchen Island Tables
 - 6A-2) Multi-media Tables
 - 6A-3) All Other Tables & Credenzas:
 - Meeting Room Tables (small, medium, large)
 - Training Tables
 - Video Conferencing Tables
 - Credenzas
 - Coffee & side tables
 - Collaborative Meeting Tables
 - Collaborative Lounge Height Meeting Tables
 - Laptop Tables



- B) Seating
 - 6B-4) Banquette Seating
 - 6B-5) Modular benching and side table units
 - 6B-6) All other Chairs:
 - Lounge Chairs
 - Sofas
 - Tablet arm chairs
 - Upholstered ottomans
 - Upholstered Stools
 - Bar Stools
 - Kitchenette chairs
- C) Freestanding Lounge Screens
 - 6C-7) Mobile Whiteboards
 - 6C-8) All other screens:
 - Freestanding Lounge Screens
 - Mobile Monitor Mounts
- 6D-9) Open Area Work Pods

A82. In the interests of encouraging participation by a broad range of bidders while considering the overall interests of the CRA, some furniture products have been removed from the mandatory products list at Appendix A: Detailed List of Furniture Products. These furniture products have been incorporated into a new point-rated criterion R5 - ENHANCED PRODUCT LIST for Category 3 furniture that will award points when proposals include one or more of the furniture products that were previously mandatory. Please see Amendments to the RFP item Amend41, Amend42 and Amend43 below.

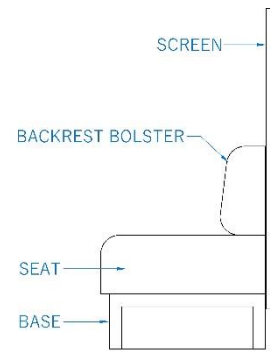
Q83. Q&A 68/69 Clarification. The pricing tables do not include all panel types shown in the layouts. In the current format, there will not be a true price comparison between bidders, nor will you have a complete appraisal of the costs associated with the layouts provided. Please revise the table to include the following Panel Types which are part of the layouts:

- 24" Fabric both lower sides, seated privacy height, whiteboard on both sides of upper portion, powered, no outlets
- 24" Fabric both lower sides, seated privacy height, whiteboard on ones side of upper portion, power with outlet below work surface one side.

A83. The Financial Proposal for Category 2: Table E: Regular Hours Installation will not be modified. Whiteboards are only specified on panels 48 inches wide per the workstation typicals. Please refer to A69 which indicates that bidders are to supply the components as specified in the original floorplan provided in the RFP.



- Q84. Q&A 73 Clarification: 6.6.14.1.2 indicates a back rest is required, however, Items C7, C8, C10 and C11 reference the “backrest bolster” as one item which contradicts 6.6.14.1.5. Please confirm that the backrest bolster is one piece (as per attached “Defined parts of Banquette Seating” diagram). Please delete 6.6.14.1.5 or revise to indicate that a separate additional bolster can be provided if part of the manufacturer’s standard offering, since having an additional bolster would not change the functionality of the Banquette seating. For example, 6.6.14.1.5, could say, “Can be available with or without optional additional bolster, as per manufacturer’s standard offering”.



DEFINED PARTS OF BANQUETTE SEATING

- A84. 6.6.14.1.5 will be removed. Please see Amendments to the RFP item Amend44 below.
- Please be advised that C7, C8, C10 and C11 will be deleted from Table D, E and F for Category 3 and the mandatory list of furniture products at Appendix A: Detailed List of Furniture Products. Refer to the new point-rated criterion R5 - ENHANCED PRODUCT LIST for additional products that may be proposed by Bidders. Please see Amendments to the RFP item Amend41, Amend42 and Amend43 below.
- Q85. Q&A 75 Clarification: 6.6.20.1.2.1. Please consider the overall layout and allow for tolerances of 25” to 48” +/-1” to allow for Manufacturer’s standard offering, otherwise, we cannot bid on any of Category 3.
- A85. The acceptable width measurement will be modified. Please see Amendments to the RFP item Amend45 below.
- Q86. Q&A 75 Clarification: 6.6.20.2.2.1. Please allow for tolerances of +/- 2.5” (instead of 2”) to allow for Manufacturer’s standard offering, otherwise, we cannot bid on any of Category 3.
- A86. Agreed. A tolerance of +/- 2.5 in (+/- 63.5 mm) is acceptable. Please see Amendments to the RFP item Amend46 below.
- Q87. Q7A 76 Clarification: 6.6.21.2.2.1. Please allow for tolerances of +/- 2.5” (instead of 2”) to allow for Manufacturer’s standard offering, otherwise, we cannot bid on any of Category 3.
- A87. Agreed. A tolerance of +/- 2.5 in (+/- 63.5 mm) is acceptable.
- Please see Amendments to the RFP item Amend47 below.
- Q88. Q&A 78 Clarification: When whiteboard one side and glass on the other side is requested, please confirm that glass both sides is acceptable if the glass is a writable surface (i.e. back painted glass), as per manufacturers standard offering.
- A88. Yes this is acceptable as long as there are additional offerings that include a whiteboard on at least one side. Please be advised that this product will be deleted from the mandatory list of furniture products at Appendix A: Detailed List of Furniture Products. Refer to the new point-rated criterion R5 - ENHANCED PRODUCT LIST for additional products that may be proposed by Bidders. Please see Amendments to the RFP item Amend41, Amend42 and Amend43 below.
- Q89. 6.6.10.1.12 The specification here is only for Counter height and Bar Height, however the tables T6 & T8 are for seated height (29”) tables. Please add ‘seated height’ to the specification details.



A89. Item T6: this item does not refer to a kitchenette island table and is for a seated height table. Please see Amendments to the RFP item Amend41 below for clarification.

Item T8: the specification for kitchenette island tables is for counter or bar height, and will not change. Please be advised that T8 will be deleted from Table D, E and F for Category 3 and the mandatory list of furniture products at Appendix A: Detailed List of Furniture Products. Refer to the new point-rated criterion R5 - ENHANCED PRODUCT LIST for additional products that may be proposed by Bidders. Please see Amendments to the RFP item Amend41, Amend42, and Amend43 below.

Q90. Item T6 is requesting “without modesty panel”, however modesty panels are not mentioned in the technical specification (6.6.10.). Please confirm that although a modesty panel is not required, where a partial modesty is a structural component of the table this is acceptable. Please also confirm that there is no expectation of full-height modesties with these tables.

A90. Modesty panels will be accepted when it is a structural component of the table. Note that 6.6.10 does not apply, as this is not a kitchenette island table.

Please see Amendments to the RFP item Amend41, Amend42, and Amend43 below.

Q91 6.6.2.5 technical specifications make no mention of casters, however B2 requests casters on a panel supported table. Casters are not recommended for panel or column bases or on tables 96” long or larger and should only apply to small meeting tables with post legs (see B4). Since casters are not required in 6.6.2, please delete item B2.

A91. Item B2 will not be deleted. The specification for casters will be removed from items B1, B2 and B3 in Table D of the financial proposal for Category 3.

Please see Amendments to the RFP item Amend41 below.

Q92. 6.6.2.5. When a post-leg base can provide integrated & concealed cable management to the floor, can the requirement for a center column be removed?

A92. 6.6.2.5 does not require a centre column.

Please see Amendments to the RFP item Amend48 below.
