CCVE Preventative Maintenance

Amendment 002 is raised to address industry questions.

Q1. Regarding Annex A:

"Item 6. Maintenance & Support Services, Please note: Please note: **For information purposes the following is provided: Approximately there were 233 break/fix work orders issued during the last one year period for Maintenance & Support services of which 153 required on site visits and the other 80 were addressed by phone/e-mail. Offerors should take into consideration these statistics while submitting their financial offer.**"

Based on the statistic above that this contract is to only include ~30% of the sites will require technical resources at site and the remaining services will all be done remotely by phone and email?

- R1. Whether technical services require a site visit to address a work order is dependant upon the issue and is not related to a site. Example: If a failed device cannot be reset remotely then a site visit will be required for replacement and configuration, however if a simple device (e.g. monitor) fails a replacement can be shipped and the client talked through the process to change it.

Q2. Item 10. Camera Housings

i. Q: Cell Specific housings, do the current cell housings have any coatings (epoxy or caulking) that holds the housings to the walls preventing them from being removed?

ii. Q: If so, please detail this information and provide an approximating time to remove and re-apply if required. Who is responsible for supplying this coating if required?

- R2. i. Yes, there are approved pick proof sealants for use within the cells to prevent any personal hazards or injury from occurring. The sealant must provide a complete seal between the cell surface and the perimeter of the housing.
ii. With proper tools it takes approximately thirty minutes to remove a cell housing and can take up to another thirty minutes to prepare it for reinstallation. The installation process can take up to thirty minutes to reapply sealant.

Q3. Annex B:

"Item B. RCMP Closed Circuit Video Equipment (CCVE) Standards, 1.2 RCMP Closed Circuit Video Equipment (CCVE) Standards Evergreen: Capable of transferring data from old server to new server with Minimal to no impact on services."

Please define "minimal", and the expectation around this disruption. What definition is deemed minimal, and then beyond? What are PTSS's expectations?

- R3. The intent is to not have a cellblock 100% inoperable at any given time. As such, minimal refers to the time required to move devices individually from the old server to the new server and the time required to replace an individual device. The video archive transfer should, wherever feasible, be completed without impacting the operation status of the cellblock. Evergreen efforts will be planned and coordinated with the site Commander and PTSS to identify any potential impacts to operations so that the Commander can prepare accordingly for disruptions beforehand.

- Q4. Regarding Annex B – Mandatory Technical Criteria, Section B, Item #6.1, are bidders permitted to subcontract the Electricians?

- R4. Electricians can be subcontracted as long as they meet RCMP clearance requirements.

- Q5. We would like to request a two-week extension to the closing date of the RFP.
