1. Address the following questions submitted during the solicitation period as per RFP.

Bidders are reminded that, in accordance with Section 2.4 Communications - Solicitation Period SACC A0012T (2014-03-01) of the RFP, the timeline for submission of enquires has now lapsed and as such any further enquiries may not be answered.

1. QUESTIONS AND ANSWERS

- Q99. With the new revised Category 3 Collaborative and Support Space Furniture Table D; Item B1 and B2 now have identical descriptions and sizes. Do you still require each line item listed separately?
- A99. Yes each line item should be listed separately in accordance with the updated financial proposal tables provided in solicitation amendment 008.
- Q100. Category 2: Panel Systems Table E; Panel type E9 states "whiteboard on upper portion" and has a quantity of 8 required. Given Annex 3 Appendix A - Model Workstation Layout (Original), we have 7 panels with whiteboards on both sides, and 1 panel with a whiteboard on one side (wkstn 145). In order to capture this difference, please add an additional panel type to this table.
- A100. For evaluation purposes, only a single panel type will be required. Whiteboards should be proposed on both sides of these 48" wide panels, including in workstation 145.
