**1. Questions and Answers**

**Question 1**

The Reference Project definition in Appendix A to Annex E requires that all reference projects for all categories include client reference information. Since it is common for client contacts to have changed positions, retired, or are deceased, this type of request could cause serious delays at the time of Task Authorizations. We respectfully ask IRCC to amend the requirement to instead request client references for two (2) projects within the last five (5) years of bid closing date or, if the proposed resource has been continuously contracted to the same organization for the last five (5) years, include one reference for the full five-year period?

**Answer 1**

The request has been reviewed and the requirement will remain unchanged. As a clarification, the Definitions are at Appendix E of Annex A.

**Question 2**

On page 123, M6, Cloud Implementation Specialist – Level 3, The Bidder must demonstrate that the proposed resource holds at least 1 valid professional certification of either the Amazon Web Services Certified SysOps Administrator; Amazon Web Services DevOps Engineer; or Microsoft Certified Azure Administrator Associate.

A) Would the Crown please consider accepting the following certifications in addition to those being requested? Many of these are recognized in higher standing than the certifications that are being asked for.

- AWS Associate Developer Certificate
- AWS Associate Solution Architect Certificate
- AWS Associate Solution Architect Certified
- AWS Cloud Practitioner Certificate
- Microsoft Certified: Azure Solutions Architect Expert
- Microsoft Certified: Azure Security Engineer Associate
- Microsoft Hybrid Cloud with Azure stack
- Microsoft Azure Associate Security Administrator

B) Would the Crown accept a certification that has recently expired for any of these categories?

**Answer 2**

A) Canada will not consider additional AWS certifications for M6 Cloud Implementation Specialist – Level 3.

Canada will consider the Azure DevOps Engineer Expert Microsoft Certification in addition to the Microsoft Certified Azure Administrator Associate.

B) Canada will not accept a certification that has recently expired for any of these categories.

**Question 3**

Due to the delays in receiving answers to questions that resulted in multiple amendments that have changed the nature of both Corporate and Resourcing requirements, many bidders have been asking for an extension to the bid closing date. We understand that IRCC has an immediate and pressing need for this requirement; however, we would like to strongly request an extension to October 7, 2021 to ensure that all bidders are able to provide fully detailed and developed bids. The Crown has invested a lot of money and resources in this RFP process and allowing for this short extension will ensure that the Crown is able to secure the caliber of resources that are required for IRCC to be successful during implementation. We are confident that allowing bidders this little bit of extra time will make bids clearer and easier for the Crown/IRCC to evaluate and ultimately ensure a quicker contract award.
