PART 1 - GENERAL INFORMATION

1.1 Security Requirements

PART 2 - BIDDER INSTRUCTIONS

2.1 Standard Instructions, Clauses and Conditions

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the [Standard Acquisition Clauses and Conditions Manual](https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual) (https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual) issued by Public Works and Government Services Canada.

Revision to Departmental Name: As this solicitation is issued by Royal Canadian Mounted Police (RCMP), any reference to Public Works and Government Services Canada or PWGSC or its Minister contained in any term, condition or clause of this solicitation, including any individual SACC clauses incorporated by reference, will be interpreted as reference to RCMP or its Minister.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

The [2003](#) (2020-05-28) Standard Instructions - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the bid solicitation.

Subsection 5.4 of [2003](#), Standard Instructions - Goods or Services - Competitive Requirements, is amended as follows:

Material supplied must be new and conform to the latest issue of the applicable drawing, specification and/or part number that is in effect on the bid solicitation closing date.

2.2 Submission of Bids

Bids must be submitted only to RCMP Bid Receiving Unit by the date, time and place indicated on page 1 of the bid solicitation.

NOTE: The RCMP has not been approved for bid submission by epost Connect service.

Due to the nature of the bid solicitation, bids transmitted by facsimile or email to RCMP will not be accepted.

2.3 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than seven (7) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to



enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

2.4 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Quebec.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

2.5 Promotion of Direct Deposit Initiative

The following information is not related to the solicitation process:

An initiative within the Government of Canada called the Cheque Standardization Project has been established whereby eventually for all payments, cheque stubs will no longer be printed and, with few exceptions, will be processed via direct deposit. This option is only available when payment is made in Canadian dollars for deposit into a Canadian bank account. In an attempt to be proactive, RCMP Corporate Accounting is promoting the registration of RCMP suppliers for the upcoming change in the payment process.

3.1 Bid Preparation Instructions

Canada requests that Bidders submit their bids in separately bound sections as follows:

Section I: Technical Bid - 3 hard copies

Section II: Financial Bid - 1 hard copy, **Sealed envelope**

Section III: Certifications - 1 hard copy

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

Canada requests that bidders follow the format instructions described below in the preparation of their hard copy bid:

- a) use 8.5 x 11 inch (216 mm x 279 mm) paper;
- b) use a numbering system that corresponds to the bid solicitation.

In April 2006, Canada issued a policy directing federal departments and agencies to take the necessary steps to incorporate environmental considerations into the procurement process [Policy on Green Procurement](https://www.tbs-sct.gc.ca/pol/doc-eng.aspx?id=32573) (https://www.tbs-sct.gc.ca/pol/doc-eng.aspx?id=32573). To assist Canada in reaching its objectives, bidders should:

Unless specified otherwise, Canada will declare a bid non-responsive, or will declare a contractor in default if any certification made by the Bidder is found to be untrue whether made knowingly or unknowingly, during the bid evaluation period or during the contract period.

The Contracting Authority will have the right to ask for additional information to verify the Bidder's certifications. Failure to comply and to cooperate with any request or requirement imposed by the Contracting Authority will render the bid non-responsive or constitute a default under the Contract.

2. When making deliveries, sufficient personnel must be provided to permit unloading of any type of vehicle without the assistance of federal government personnel.
3. At some sites, the delivery truck must be unloaded while parked at the curb. When material is placed on the sidewalk, it must be placed in proximity to the designated entrance so as to be readily accessible to transport by mechanical handling equipment utilized by site personnel.



ANNEX "A"

STATEMENT OF REQUIREMENT

Hydraulic Door Opening System

1.0 Background

The Royal Canadian Mounted Police C Division ERT has a requirement to acquire a hydraulic door opening system with a minimum spreading/opening force of 68 kN (kilonewtons) and a minimum working pressure of 26,000 IPa (Atmospheric Protection Index). These spreading/opening forces are mandatory in order to ensure members' safety when using the hydraulic system for the following: barricaded doors, flammable laboratory environments, CBRN (Chemical, Biological, Radiological, Nuclear) operations, and clandestine laboratories. As these environments contain hazardous materials, the door will need to open quickly.

2.0 Requirements

The vendor must supply a hydraulic door opening system that meets the following specifications:

Quantity: 1 system

- 2.1 Must be able to open inward-opening doors. Door materials: metal, wood, and PVC (polyvinyl chloride). Lock types: single and multiple locks;
- 2.2 Must have a minimum spreading/opening force of 68 kN (kilonewtons) and a minimum operating pressure of 26,000 IPa (Atmospheric Protection Index);
- 2.3 Must have remote activation with both wired and wireless control options;
- 2.4 Must use rechargeable batteries;
- 2.5 Must have at least an IP65 rating (Liquid and Solid Protection Rating) or equivalent;
- 2.6 Must operate in relative humidity of 40% to 100%;
- 2.7 Must operate in temperatures between -19 °C and +39 °C.

The vendor must supply the following accessories:

- 2.8 Telescopic rod system for installation on doors;
- 2.9 Extension bracket(s) to support operation on double doors;
- 2.10 Pressure hose of 1.5 meters;
- 2.11 One (1) set of batteries with a charging system.

The vendor must supply a battery charging system with the following:

- 2.12 A 100 VAC-220 VAC (volts alternating current), 50 Hz-60 Hz (voltage) universal power input with a North American plug;
- 2.13 Visual indicators of battery charge to signal when charging is in progress and when it is complete;
- 2.14 The battery charging system must take no longer than three days to fully charge one (1) set of batteries.



3.0 Deliverables

The vendor must supply one hydraulic door opening system, including:

3.1 Basic online training via Microsoft TEAMS for three participants, either in English, in French, or in both languages;

3.2 Technical support by phone or online for one year, either in English, in French, or in both languages;

3.3 English, French or bilingual versions of technical documents will be accepted and must be sent by email to the technical authority designated in section 6.5.2.
