The Request for Proposal (RFP) Amendment 001 is raised to answer Bidders questions.

QUESTIONS AND ANSWERS

Question 1

Mandatory Criteria M1 requires vendors to demonstrate contracts awarded within the past five years, given the scope of experience requested, the considerable value of the contracts requested, and the relatively limited number of contracts which support PeopleSoft there are very few contracts awarded within this timeframe which fully comply with M1. In order to promote a competitive solicitation process and accommodate experienced and capable vendors who otherwise meet all the requirements within the solicitation would the Crown please amend M1 to accept contracts which have been active within the past 5 years prior to the solicitation posting date.

Answer 1

No, the requirement remains unchanged.

Question 2

Mandatory Criteria M1 required vendors to cite two contracts involving PeopleSoft HCM, given the similarity in scope and the overlapping skillsets and required would the Crown also accept contracts which involved Siebel CRM.

Answer 2

No, the requirement remains unchanged.

Question 3

For M1 in both Workstreams please confirm that the \$5 million is excluding taxes in order to demonstrate \$5 million in delivered services. N.B. Many Government of Canada contracts have varying tax rates depending location of the contracting authority with tax rates ranging from 5% in Alberta up to 15% in other provinces. Therefore, for the sake of clarity and fairness, we suggest that the \$5 million in services BEFORE taxes.

Answer 3

No, the \$5M is including taxes.

In M2 and R1 (both workstreams) should not PeopleSoft experience be the only valid billable days considering that the RFP only mentions PeopleSoft and no other ERP in both Workstreams, resource grids and the Statement of Work/Definitions? For example, we are struggling to understand how billable days for a .NET ERP Programmer Analyst would qualify a bidder for PeopleSoft services. Accordingly, can PSPC please change the RFP evaluation criteria for M2 and R1 such that it reflects PeopleSoft services only so it aligns with the stated needs and scope of work for the resulting contract?

Answer 4

No, the requirement remains unchanged.

Question 5

In both Streams please confirm that since R2 and R3 both build on M1 then a contract must have a billed value of \$5 million dollars (before taxes) in services in order to qualify.

Answer 5

No, the requirement remains unchanged.
