Amendment 001

This amendment is raised to distribute questions and answers and to make changes to the tender package.

A. Questions and Answers

Q1 There seems to be a conflicting statements made regarding where to include Annex C Bid Price Form in our bid submission. On page 18, in Section 1: Bid Form and Content Requirements, Part 2 – “Price Portion”: instructs “Complete one copy only of the Bid Price Form (Annex C), and enclose it together with the bid security in a separate submission...”. However, on page 19, Section 3: TECHNICAL EVALUATION, QUALIFICATION FORM (SUBMISSION 1), Submission 1, the third circular bulleted list statement “Bid Security included with Bid Price Form (Annex C) seems to be instructing that Annex C should be included with Submission One – TECHNICAL QUALIFICATIONS SUBMISSION.

A1 Please include Annex C – Bid Price Form with Submission 2, and not Submission 1

Q2 Also on page 19, Section 3: TECHNICAL EVALUATION, QUALIFICATION FORM (SUBMISSION 1), SUBMISSION 2 (near the bottom of the page) instructs that the Bid and Acceptance Form (BA) should be included within Submission 2. However, we are unable to find the Bid and Acceptance Form. Can you please direct us to its location within the documentation provided?

A2 The Bid and Acceptance Form (BA) is an error and should read Annex C – Bid Price Form

Q3 Are we to include the supply of all of the weather monitoring equipment or will that be provided? If these are being provided, would you have the equipment specifications available that shows the dimensions and weights? This will be need in order to design the towers.

A3 Design, supply and install of all weather monitoring equipment is the responsibility of the Contractor as indicated in:

Section 01 11 00 Clause 1.3.6

“Weather station” refers to all structures, foundations, instrumentation, hardware, software and additional infrastructure installed at a single location according to these Contract documents, and may include multiple structures including towers, pedestals, and enclosures.

Section 01 11 00 Clause 1.5.2

Without limiting the scope of work, the work of this Contract generally comprises the following, as directed by the Departmental Representative:

.1 Design, supply and installation of two (2) new weather stations in two (2) remote locations, including two (2) towers and one (1) precipitation pedestal, required foundations and/or rock anchors, and all associated instrumentation, hardware and software.

Section 33 42 36 Clause 1.5.2.1

The Contractor must design all components, including but not limited to sensors, instrumentation, mounting hardware, connectors, power sources, housing, communications technology, and lightning protection, to ensure a minimum effective service life of 10 years.
