Optional Site Visit

General Information:

The optional site visit(s) at the Research and Development Centre (RDC) located as 204 Brookfield Road, St. Johns will take place on September 28th, 2021. Site visits may also take place on September 29th, but only if we exceed the maximum availability on the 28th. Each site visit is estimated to take approximately 2 hours. Please keep in mind that attending the site visit will be the only way bidders will be able to see the site in its entirety.

Due to building protocols as well as Covid 19 restrictions, one site visit will be limited to ten (10) individuals. To accommodate as many firms as possible, all firms will be **limited to two (2) individuals** allowed to register for a site visit.

Building Protocols:

- The limited number of individuals per site visit is to allow for social distancing.
- A sign in sheet will be available to you upon your arrival.
- Masks are required.

Questions during site visit:

As the site visit is ongoing, any technical questions or questions related to the project itself will not be answered on the spot. We will issue question and answer amendments from the site visit so the information is available to all bidders. Bidders are reminded to ensure they bring a smart phone or a paper and pen to record their questions.

Note to bidders:

Bidders who do not attend or send a representative will not be given an alternative appointment but they will not be precluded from submitting a bid. Please note that this will be the only site visit for this project. No other site visits will be arranged during the tender period.
