1. Questions and Answers

Question 1

In regard to Application Software Architect: Cloud Solutions Architect, for R8 on page 121, the Bidder should demonstrate, that the proposed resource has experience in the past 10 years of the RFP issuance date designing the architecture of cloud solutions designed to meet the Government of Canada Protected B Medium integrity Medium availability (PBMM) Profile. PBMM is still very new to the GoC and there are very few resources that would score full points having 2 years or more of this experience. The Ontario Provincial Government Security Frameworks uses a medium integrity and medium availability profile that include WAF, Azure Security Center, Azure Key Vault, Cloud Access Security Broker (CASB), Identity and Access Management (IAM), Security Solutions, IOT (Internet of Things) Hubs and Resources, Resource Security Hygiene, Policy and Compliance, Advanced Cloud Defense, ATP-Advanced Threat Protection, Encryption, VNET restrictions for multiple platforms and subnets as well as Azure CIS, ISO 27001 and SOC2 compliance. Since this profile is very similar to the GoC PBMM profile, would the Crown consider awarding points for Government of Ontario experience with a medium integrity and medium availability profile?

Answer 1

The request has been reviewed and the requirement will remain unchanged.

Question 2

Given that today (September 15, 2021) is the last day to ask questions and we have yet to receive responses to other questions that have been submitted, we are very concerned about the tight timelines to deliver a well substantiated proposal. It is unreasonable to expect bidders to be able to submit a quality compliant bid without providing all the required information for them to make important resourcing decisions. We implore the Crown to at minimum grant a 2-week extension, changing the closing date to October 7, 2021.

Question 4

We request the IRCC reconsider to allow a broader range of qualifications from both federal *and* provincial and municipal departments, Crown Corporations and agencies. The expansion to other levels

of government reduces the Crown's risk. Bidders who have multi-jurisdictional experience are adept at understanding and meeting client-specific requirements for development, IT Security security implementation, data management, and have Cloud specific expertise *including* GoC specific Cloud standards for the following reasons: i) expertise required to establish Cloud Delivery Support Services vis a vis skillsets is the same so long as the scope and complexity is the same; ii) Federal Departments and Crowns each have unique Cloud requirements (for example ESDC adheres to DESDA policy with regards to data management/data security and CRA uses a different policy). As government entities, provincial and municipal departments, Crowns and agencies have similar strict personal data requirements and similar constraints around development, IT security implementation and data management and could have more similarities with a department like IRCC than another government department. It is incumbent upon IRCC that they engage with firm(s) that have a wider breadth of Cloud experience and can apply current best practices to the unique standards of IRCC. We therefore recommend that the Crown expand the requirement to include provincial and municipal departments and agencies.
