Advanced Contract Award Notice

Title: Seal Cove Base Garbage Bin Rental and Garbage Pick-Up.

1. ACAN

An ACAN is a public notice indicating to the supplier community that a department or agency intends to award a contract for goods, services or construction to a pre-identified supplier, thereby allowing other suppliers to signal their interest in bidding, by submitting a statement of capabilities. If no supplier submits a statement of capabilities that meets the requirements set out in the ACAN, on or before the closing date stated in the ACAN, the contracting officer may then proceed with the award to the pre-identified supplier.

2. Definition of requirement


The Department of Fisheries and Oceans has a requirement to supply all equipment, materials and labor to provide Waste Management Services including the collection, removal and disposal of general trash, recyclable cardboard bins and wood bins in accordance with attached site plans, from the Canadian Coast Guard Base located 2501 Seal Cove road. This service will include the supply of garbage containers complete with closable lids. Each container must be clearly identified for the contents permissible to be deposited. All containers must be in good condition, no serious external damage, no perforations due to corrosion, all components in good working order.

3. Tasks

The Contractor must ensure that the garbage, waste paper, crating, building, recyclable materials and organics will be disposed of completely and/or recycled in such a manner that the Crown is relieved of all further responsibility for such disposal, and respects the local recycling programs. Any paper, liquid, dry debris, etc., spilled during the emptying of any container(s) must be completely picked up/cleaned up and disposed of immediately. All Containers are subject to the approval of Fisheries and Oceans, Seal Cove Base RPSS Facility Manager



4. Criteria against which the statement of capabilities submitted by potential suppliers will be assessed.

The supply of (size) garbage containers of adequate size to support the volume of waste described below complete with closable lids.

6. Justification for the Pre-Identified Supplier

At this time, There is only one service provider in the area able to fulfil these specific requirements for waste removal. Due to the remote nature of the this location, there are no other service providers situated within the local area.


7. Government Contracts Regulations Exception(s)

The period of the contract is from approximately October 1st, 2021 to March 31, 2022 inclusive. The contract will include 3 optional phases each of 1 year duration, to be exercised at the discretion of DFO.

Option Period 1: April 1, 2022 to March 31, 2023 Option Period 2: April 1, 2023 to March 31, 2024 Option Period 3: April 1, 2024 to March 31, 2025

The estimated value of the contract is \$24, 234.00+ (GST/HST extra) annually.
