Question 11

Question 12

In M2 for both Streams, please confirm that PSPC will accept experience under a TBIPS contract in the exact same TBIPS category and level as a 100% match.

Answer 12:

To be considered, the Bidder must demonstrate compliance with all the requirements of the mandatory M2.

Question 13

Please confirm that if the billable days in presented for M2 are certified by the Bidder as being for a TBIPS contract in the exact same TBIPS category and level then no further substantiation is required for the bid.
