Question 1:

The Contractor's Use of Site section seems to insinuate that wharf will be shared with ongoing lobster fishing operations throughout the construction period... Is there a designated laydown and/or work area for the contractor?

We would like to store the following items on the wharf:

- Departmental Representative's Site Office
- Contractor's site office/tool crib
- Washroom facilities
- Work Truck(s)
- Stockpiled material for disposal (e.g. SSP)
- Stockpiled new material (e.g. timber piles)
- Construction equipment (crane, loader, et al.)

Can you kindly confirm if there will be a defined space the contractor can use exclusively? And if not, who has authority to designate a work area for the contractor? We want to confirm the contractor will be entitled to safely & efficiently work from the wharf... Based on a site visit yesterday, we are concerned the wharf may be quite congested.
