REQUEST FOR QUOTATION AMENDMENT NO. 005

Request for Quotation Amendment no. 005 is raised for the following reason:

- To address questions pertaining to the KVM specifications;
- To modify the excel 2BH195275A attachment C Substantiation of Technical Compliance, the excel 2BH195275A- Annex B – List of Deliverables and Prices, and Annex C – Delivery Locations.
- To extend the solicitation closing date.

Question 14

Given the answer to question 5 in Amendment 002, are we correct in understanding that the Secure KVM Switch required must be a universal secure KVM switch with both HDMI and DisplayPort inputs but the output should be DisplayPort connecting to the monitor?

Please review revised Statement of Requirement and List of Deliverables.

Question 15

It is very unclear how many of each item is being purchased after reviewing Annex B List of Deliverables and Prices. Annex B only identifies one item, which is in conflict with the Annex A – Statement of Requirement (SOR). For example, in Annex A n) it states: "Must include all necessary cables to connect two devices & CAC devices". Since this Annex A n) is referring to items beyond the Item 1 shown in Annex B List of Deliverables and Prices, then these cables must be shown in Annex B as other items. When in Annex A n) it asks for cables to connect two devices, does this refer two monitors, and if so, what port in the monitors that are owned by DND do these cables need to be connected to, and what are the descriptions of these monitor ports (IE: Male, Female, HDMI, DisplayPort, etc.)? Also, if cables are necessary to connect CAC devices then how many CAC device cables are required, and what are the descriptions of these CAC ports (IE: Male, Female, etc.)? Will SSC please amend the Annex A – Statement of Requirement (SOR) to provide the detailed information requested, and also amend Annex B List of Deliverables and Prices to include the additional items and quantities for the items that refer to cables?

Question 16

Items j) and k) in Annex A – Statement of Requirement (SOR) both refer to "1 x DisplayPort/HDMI combo ports", which limits the competition to one OEM that has these combo ports, when products from other OEMs that have both DisplayPort and HDMI ports can meet these operational requirements. Therefore, will SSC amend these requirements in Items j) and k) in Annex A to allow "1 x DisplayPort/HDMI combo port"; or 1 x DisplayPort and 1 x HDMI combo port"?

Question 20

In the Annex A – Statement of Requirement (SOR) "Annex A a)" it states: "& CAC support"; and in "Annex A j)" it states: "& USB A (CAC support)"; and in "Annex A k)" it states: "& USB B (CAC support)"; and "Annex A n)" it states: "Must include all necessary cables to connect two devices & CAC devices". To ensure fair and open competition between more than one OEM for this requirement, will SSC please remove all references to requirements for CAC support?

Question 21

Based on Amendments 1 and 2, and the amendment to Annex B List of Deliverables and Prices, it is now more unclear regarding the items and quantities required.

For Annex B Item 2, you are requesting "Cables to connect devices & CAC device (Dongles will not be accepted)" and you are stating a quantity of 642.

Annex A Item 2 really only takes care of 2 device Cables per KVM switch for the 2 Computer Ports described in Annex A (k) to connect to 2 devices (hence Qty 642); as described in Annex A (n), and then it states "& CAC device", which is a separate cable.

There needs to be a separate Annex A Item 3 for CAC cables with a description something like "TAA Compliant Cable CAC USB A/B SKVM CABLE (6 FT Minimum)", and how many of these are required? Is it 321 or 642?

We believe that there also needs to be a separate Annex A Item 4 for video cables with a description something like "TAA Compliant Cable DP/DP Male to Male (6 FT Minimum)", and how many of these are required? Is it 321 or 642?We also believe that there needs to be a separate Annex A Item 5 for audio cables with a description something like "TAA Compliant Cable Audio Male to Male (6 FT Minimum)", and how many of these are required? Is it 321 or 642?We also believe that there needs to be a separate Annex A Item 5 for audio cables with a description something like "TAA Compliant Cable Audio Male to Male (6 FT Minimum)", and how many of these are required? Is it 321 or 642?

Can you please amend Annex B List of Deliverables and Prices again to precisely describe all of the items and quantities for all items, starting with Item 1, and then covering all item numbers that refer to cables? Can you also please amend Annex B to make this more clear.
