## **QUESTIONS**

**Question 1 :** Can you please explain to me that what it is and how I can apply for this

**Answer 2:** A standing offer is an offer from a potential supplier to provide goods and/or services at pre-arranged prices, under set terms and conditions, when and if required. It is not a contract until the government issues a "call-up" against the standing offer. (See Buy and Sell web site.)

**Question 2:** In the past, as a U.S. firm, we would not be eligible for this initial round of bidding and would only be eligible later if no Canadian firms were deemed worthy of meeting the requirements of the proposal. Has that process changed?

We noticed on the website the following statements:

Trade Agreement: Canadian Free Trade Agreement (CFTA) Tendering Procedures: If 2+ bids offer Canadian goods/services other bids will not be considered Competitive Procurement Strategy: Lowest/Lower Bid

Does this imply that we should also bid in the first round and if two or more Canadian firms have not submitted an application then we would also be considered in this first round? And is it ANY two Canadian firms that submit an offer - or any two Canadian firms that submit an offer AND meet the prescribed requirements?

**Answer 2:** As mentioned in section 1.2.2 Canadian Content Certification *SACC Manual* clause A3051T (2018-12-06) Canadian Content Certification; If 2+ bids offer Canadian goods/services other bids will not be considered
