Questions Submitted to PWGSC

Question #1

Confirm that the site is responsible for preparing the items for internal inspections?

Answer to Question #1

Preparation will be performed by the client department who is the owner of the equipment.

Question #2

Section A11 non-destructive testing states the inspector may request NDT if an internal is not a practical option. We believe it would be best technically and economically if this work was performed by the inspector at the time of inspection. In this case is a separate NDE report required, or should NDE reporting be comments on the ROI?

Answer to Question #2

If it is deemed that a non destructive test is required it would be funded by the client and is not part of this contract. If an NDT is deemed to be required, the client will schedule the NDT service provided by the company of their choice or opt to replace the equipment instead of funding an NDT examination so the work cannot be performed at the initial visit.
