Modification 014

On page 14 of the Solicitation, at 5.10 Delivery Date, a);

Delete: All Firm Deliverables must be received on or before 30 federal government working days from Contract award, however the global pandemic has resulted in supply chain and logistics constraints and may cause significant delays in the delivery of the order.

Replace with: All Firm Deliverables must be received no later than 90 federal government working days from Contract award or by March 31, 2022 whichever is sooner.
