The following changes in the tender documents are effective immediately. This Addendum will form part of the contract documents.

Questions and Answers

Question #1 What utilities are available on site?

Answer #1 Only electrical power is available to the PEC Site via primary overhead electrical transmission lines. The Contractor is responsible for identifying if the connection point is sufficient and for any modification to the existing services to meet their needs. Alternatively, Contractor may supply their own generators

Question #2 Are there any permits related to the trees that are required?

Answer #2 Yes, a Timber License is required for the tree removal. Canada is responsible for obtaining this license. In the event that the license is not forthcoming, other areas of work at the site will be identified where tree removal is not required.

Question #3 The Test Pit Soil Analytical Results provided in the specifications note the area of "Excavation Southwest Portion of the site". Is the analytical data provided representative of the contaminated soil to be removed under this scope of work?

Answer #3 Yes. The "Excavation Southwest Portion of the Site" is referring the excavation program as part of this RFP.

Question #4 Can you advise what the invasive species which will require disposal are?

Answer #4 An invasive plant survey of the entire site produced the following results:

- Himalayan Blackberry – Dominant invasive species throughout the site.
- English Ivy – Where Himalayan BlackBerry not present, English Ivy was observed along the upland floor. Numerous trees observed to have ivy all the way up to the crown of the tree.
- Scotch Broom – Observed in patches throughout the upland area. Predominantly along the treed edges.
- English Holly – Observed sporadically throughout the uplands area.
- Cherry Laurel - Observed sporadically throughout the uplands area.
- Daphne - Observed sporadically throughout the uplands area.
- Periwinkle - Observed sporadically throughout the northwest corner of the uplands area.
- Bamboo - Observed sporadically throughout the northwest corner of the uplands area.
