QUESTIONS AND ANSWERS

Question 2: RFP G9292-248331/A was Posted on Buy and Sell September 28th with a closing date of October 18th, giving Bidders only 12 full business days to prepare a response, due to two statutory holidays in-between. The standard time to recruit and vet candidates, complete grids and resume writing and prepare a proposal response is at least 1 full business day per resource. Sourcing niche SAP candidates can be even more difficult. Adding in the time required to complete the Corporate Mandatory and Rated criteria, Bidders need additional time to complete a quality proposal for consultant resources who are available and able to complete the SOW as outlined in this RFP. In order to receive high quality proposals, will the Crown please extend the closing date of this RFP to November 8th 2021.

Answer 2: The solicitation closing date has been extended by two weeks to November 1, 2021.
