Similar to the three evaluated Resource Categories, the mandatory and rated requirements for the Technical Architect and Programmer/Software Developer Level 1 in Appendix C to Annex A are very specific.

We therefore request that the mandatory and rated criteria for the Technical Architect and the Programmer/Software Developer Level 1 be added to the evaluation criteria at the RFP stage.
