SOLICITATION AMENDMENT NO. 007

This amendment is raised to:

1. Provide answers to Bidders questions in relation to the above mentioned solicitation; and
2. Amend the RFP accordingly.

Q31. In response to Q29 in Amendment 6 , Canada has modified the criteria for MTC4, the question also highlighted the issues for MTC1/RTC2 which was not addressed in the reply. The same logic would apply to this criteria as requested by several Bidders who may not be able to meet this criteria, would PSPC please confirm the same change will be applied to MTC1/RTC2 in order to ensure the maximum number of competitive bids?

A31. Canada revises the RFP as follows:

At **Form 2**, Mandatory Technical Criteria, revise **MTC1** as follows:

Insert: "Please note: For this mandatory technical criteria only, the experience of the Bidder, its parent companies, subsidiaries, affiliates or other proposed associated entities of the Bidder, or its proposed sub-contractors will be considered. Further, the bidder must demonstrate that this experience will be available to Canada during the period of the contract."

At **Form 3**, Rated Technical Criteria, revise **RTC2** as follows:

Insert: "Please note: For this rated technical criteria only, the experience of the Bidder, its parent companies, subsidiaries, affiliates or other proposed associated entities of the Bidder, or its proposed sub-contractors will be considered. Further, the bidder must demonstrate that this experience will be available to Canada during the period of the contract."

Also, Canada revises the RFP as follows:

At **Form 2**, Mandatory Technical Criteria, revise **MTC4** as follows:

Delete: "Please note: For this mandatory technical criteria only, the experience of the Bidder, its parent companies, subsidiaries, affiliates or other proposed associated entities of the Bidder, or its proposed sub-contractors will be considered."

Insert: "Please note: For this mandatory technical criteria only, the experience of the Bidder, its parent companies, subsidiaries, affiliates or other proposed associated entities of the Bidder, or its proposed sub-contractors will be considered. Further, the bidder must demonstrate that this experience will be available to Canada during the period of the contract."
