Science Merit and Alignment with Canadian Science Priorities / Criteria M14

The exchange rate appears in one of the mandatory (M14) criteria and it is ambiguous.

Our assumption is that in M14, 'exchange rate of 0.80 CAN\$/US\$' can be expressed as '1 unit of USD converted into CAD is 1.25' or conversely 'one unit of CAD converted into USD is \$0.80' to allow consistency with the values in Table 1.

As a reference we have used The Bank of Canada Daily Exchange rates are expressed as follows:

Exchange rates are expressed as 1 unit of the foreign currency converted into Canadian dollars.

A13 : As specified at sub-paragraph (a) of Section 1.2 Summary, of the ITQ, "The CAD values shown in the third column of Table 1 are based on an exchange rate of 0.80 CAN\$/US\$ and will remain unchanged regardless of any changes to the CAN\$/US\$ exchange rate in the future". This statement also applies to any other CAD values specified in the ITQ where a foreign exchange conversion was required. As such, the exchange rate provided in the ITQ is for informational purposes only but it is not relevant for the purposes of submitting a financial response given that the CAD values will remain unchanged regardless of any changes to the CAN\$/US\$ exchange rate in the future. In order to eliminate any ambiguity, reference to the exchange rate that was provided for informational purposes in the ITQ will be deleted in this ITQ amendment.

In preparing their financial response, Respondents should review, among other provisions of the ITQ, sub-paragraph a) SACC Manual clause A0220T (2014-06-26), Evaluation of Price – Bid, noting that "FOB destination" is replaced by "DDP destination", as well as sub-paragraph b) SACC Manual clause C3011T (2013-11-06), Exchange Rate Fluctuation of Section 1.4.4.4 SACC Manual Clauses, of the ITQ and Section 1.4.4.2 Tax Exclusion and Profits of Attachment 1 to Part 4 – Financial Response Preparation Instructions.
