## **Question 25**

Section 3.3, SECTION II: FINANCIAL BID bullet point d) states that "The identification of all necessary equipment, software, peripherals, cabling and components required to meet the requirements of the bid solicitation and the associated costs of these items is the sole responsibility of the Bidder". Can the Crown please confirm that this is not required and that bidders do not need to include the costs associated with the necessary equipment, software, peripherals, cabling and components required to meet the requirements of the bid solicitation?

## **Answer 25**

The requirement remains unchanged. The financial bid must include all costs for the requirement described in the bid solicitation.

### **RFP AMENDMENT**

**1. The closing date for this Solicitation has been extended to October 26, 2021.**

**2. At section 1.2 Summary, after paragraph g), add:**

This requirement is subject to the COVID-19 Vaccination Policy for Supplier Personnel. Failure to complete and provide the COVID-19 Vaccination Requirement Certification as part of the bid will render the bid non-responsive.

**3. At Part 5, Certifications Precedent to Contract Award and Additional Information, under Professional Services Resources,**

#### **COVID-19 Vaccination Requirement Certification**

In accordance with the COVID-19 Vaccination Policy for Supplier Personnel, all Bidders must provide with their bid, the COVID-19 Vaccination Requirement Certification attached to this bid solicitation, to be given further consideration in this procurement process.
