#### Solicitation Amendment No. five (005)

The following addendum to the tender documents is effective immediately. This addendum shall form part of the contract documents. All other terms and conditions remain the same.

#### **COVID-19 VACCINATION REQUIREMENT (Required with the bid)**

Please add the following SACC Manual Clauses to the bid and resulting contract documents:

1. SACC manual Clause 4013 - Compliance with on-site measures, standing orders, policies, and rules in the solicitation and resulting contract.

*Full Text:* The Contractor must comply and ensure that its employees and subcontractors comply with all security measures, standing orders, policies or other rules in force at the site where the Work is performed.

2. SACC Manual Clause A3080T – COVID-19 vaccination requirement

*Full Text:* This requirement is subject to the COVID-19 Vaccination Policy for Supplier Personnel. **Failure to complete and provide the COVID-19 Vaccination Requirement Certification as part of the bid will render the bid non-responsive.**

3. SACC Manual Clause A3081T – COVID-19 vaccination requirement certification (see attached Appendix 4)

*Full Text:* In accordance with the COVID-19 Vaccination Policy for Supplier Personnel, **all Bidders must provide with their bid, the COVID-19 Vaccination Requirement Certification attached to this bid solicitation, to be given further consideration in this procurement process.** This Certification incorporated into the bid solicitation on its closing date is incorporated into, and forms a binding part of any resulting Contract.

#### 4. SACC Manual Clause A3015T – Certification - Bid

*Full Text:* Compliance with the certifications bidders provide to Canada is subject to verification by Canada during the bid evaluation period (before award of a contract) and after contract award. The Contracting Authority will have the right to ask for additional information to verify bidders' compliance with the certifications before award of a contract. The bid will be declared non-responsive if any certification made by the Bidder is untrue, whether made knowingly or unknowingly. Failure to comply with the certifications or to comply with the request of the Contracting Authority for additional information will also render the bid non-responsive.

#### SACC Manual Clause A3015C – Certifications - Contract

*Full Text:* Compliance with the certifications provided by the Contractor in its bid is a condition of the Contract and subject to verification by Canada during the term of the Contract. If the Contractor does not comply with any certification or it is determined that any certification made by the Contractor in its bid is untrue, whether made knowingly or unknowingly, Canada has the right, pursuant to the default provision of the Contract, to terminate the Contract for default.
