The following addendum to the tender documents is effective immediately. This addendum shall form part of the contract documents. All other terms and conditions remain the same.

Addendum No. 006. This invitation to tender is hereby amended to:

(1) Provide the following questions and answers - Question 22 to 26:

Q22- Would it be possible to have pictures of the ceiling space on the 2nd floor in the areas where plumbing is impacted?

A22 - BGIS has taken pictures of the ceiling space of the 2nd floor where plumbing will be affected. Please see attached

Q23 - Drawing S2.0 it shows 2 different column repairs/reinforcing. There is only one location shown on Drawing ID 1.2 at H32. Can you please confirm where the second is located?

A23 - The second column repair/reinforcing location is at Grid K/23.

Q24 - Are masonry repairs required with the structural repairs that are found on S2.0?

A24 - Yes there are masonry repairs involving Terra Cotta encasement as shown on Column 'B' Repair Plan Detail and noted between Elevation C & D.

Q25 - Can we submit a bid for only the roller blinds section? If so, is it possible to provide the colour selections after award?

A25 - All bids have to be submitted for the **entire project**, not only one section. The roller blind bid would have to go through a General Contractor who in return will bid on the entire project. Yes, the color selection must be provided afterwards with shop drawings.

Q26 - Is there more information regarding Vinyl Apique Foot Graphic & Vinyl Apique Foot Print Graphic or are these by the owner?

A26- -Refer to specification section 08 80 00 part 2.2.1.
