QUESTIONS/ANSWERS

- Q1) Would Canada consider awarding the contract to multiple firms to ensure increased access to resources as required, as well as more equitable access to business opportunity for multiple bidders. This is practice that is increasingly commonly used by PSPC both in the NCA and the Regions.
- A1) The geographic area is for Alberta South and the estimated number of projects that would be using this service are sufficient for one firm and not large enough to justify splitting amongst multiple firms.
