Q27- In the Parks Canada Division 23 - there is a section on Seismic and Vibration Isolation 23 05 48 and it indicates that it should be applied to new work, but in in the addenda 1 Division 23 which applies to the Parole Board , that section is not there, can you clarify if it is required on this project or not?

A27 - This section is not required by code and can be removed from the project scope. Delete section 23 05 48 from the Parks Canada Specifications
