**QUESTIONS AND ANSWERS**

**Question 63:** RTC6 requests that Bidders hold an ISO Quality Management Certification to score 25 points, while any other quality management system demonstrated scores 0 points. This unfairly narrows the pool of capable Bidders from achieving a competitive score. To provide Bidders with knowledge and insight to best serve ESDC on this requirement and future requirements, we respectfully request that ESDC clarify the reasoning behind the importance and heavily weighted score placed on one singular quality management process, in this case the ISO certification.

**Answer 63:** ISO 9001:2015 certification is a globally recognised certification for quality management, which requires passing an audit by a third-party, independent auditor. Having an ISO 9001:2015 certification as a rated requirement allows ESDC to identify those firms that have met this internationally recognized standard, and as such allocate the points merited to those firms that are the best qualified to provide reliable, quality support for the Pensions program relied on by over 7 million Canadians. Note that RTC6 has been revised. Please see Solicitation Revision 28.

**Question 64:** RTC6 requests that Bidders hold an ISO Quality Management Certification to score 25 points, while any other quality management system demonstrated scores 0 points. This unfairly narrows the pool of capable Bidders from achieving a competitive score. To support the mandate of fairness and transparency throughout the bidding process, we respectfully request ESDC reconsider and allow for the allocation of partial points in RTC6 for Bidders who demonstrate a detailed Quality Management Process.

**Answer 64:** RTC6 has been revised. Please see Solicitation Revision 28.

**Question 65:** Given the complexity of the data needed to substantiate so many categories over multiple workstreams in this response, we kindly ask that ESDC extend the bid submission date by an additional one (1) week to November 9<sup>th</sup>, 2021. We hope that ESDC can accommodate this request.

**Answer 65:** The solicitation closing date will not be extended at this time.
